- 1.** Be sure to enter your correct Council number.

Grand Knight Delegate

- 2.** The current Grand Knight of your Council is automatically a Delegate to the annual meeting per the Constitution Laws and Rules of the Order and the Georgia State Bylaws. Please enter the current Grand Knight's information in this section.
- 3.** We need to know if the Grand Knight is currently planning to attend the annual meeting. Please select Yes or No.

Grand Knight Alternate Delegate

- 4.** Even if the current Grand Knight is planning to attend, an alternate for the Grand Knight Delegate should be elected and listed in this section. This should be a member who will attend and serve as a Delegate in place of the Grand Knight if for whatever reason the Grand Knight is unable to attend.

Past Grand Knight Delegate

- 5.** A member must be elected to serve as the Council's second Delegate (typically referred to as the Past Grand Knight Delegate, but being a Past Grand Knight is NOT required). This should be a member who plans to attend the annual meeting and serve as a Council Delegate.

Past Grand Knight Alternate Delegate

- 6.** A member should be elected to serve as the alternate for the Council's second Delegate. This should be a member who will attend and serve as a Delegate in place of the PGK Delegate if for whatever reason the PGK Delegate is unable to attend.

Council Certification

- 8.** Please enter the Recorder's information in this section. He must sign and date the form.

Council Seal

- 9.** The Financial Secretary MUST affix the Council seal to the form.

Form Distribution

- 10.** We will accept signed, scanned, and electronically submitted forms this year as long as the Council seal is clearly visible on the scanned document. Shade an embossed seal with a pencil, if necessary. Submit one copy via the email address listed or via US Mail to the address listed.

MUST BE RECEIVED BY MAY 5, 2026 to be entitled to representation in the State Council.

Each Delegate and Alternate Delegate should be given a copy of the form with the embossed Council seal affixed. Attending Delegates and Alternates should *each* bring this to the Convention. One copy should be maintained in your Council Files.
